

# SEASON TICKET PRIZE DRAW 2020/21

## TERMS AND CONDITIONS



1. By entering the Prize Draw entrants agree to be bound by these terms and conditions. The Promoter reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards the Promoter and the Prize Draw.
2. Employees of the Promoter or any of its associated companies or subsidiaries are excluded from entering any Prize Draw.
3. In order to enter the Prize Draw, an entrant must either:
  - (i) complete the renewal of their standard Celtic FC Season Ticket for the 2020/21 season online via the Celtic FC website ([www.celticseasontickets.co.uk](http://www.celticseasontickets.co.uk)) prior to the renewal deadline; or
  - (ii) have renewed their Celtic FC Season Ticket for the 2020/21 season through Celtic FC's direct debit automatic renewal process. For the purpose of the Prize Draw an entrant who meets either of the conditions shall be deemed to be a "Qualifying Renewal". Each Qualifying Renewal will be automatically entered by the Promoter into the Prize Draw.
4. For the avoidance of doubt, the following people will not be deemed Qualifying Renewals and will not be entered into the Prize Draw:
  - (i) anyone who renews their Season Ticket in person at the Celtic FC Ticket Office, the Celtic FC booking line or the Celtic FC customer service line;
  - (ii) anyone who renews their 2020/21 Season Ticket online after 17:00 on Tuesday, 30th June 2020;
  - (iii) anyone who is currently enrolled in Celtic FC's direct debit automatic renewal process but who cancels their Season Ticket prior to Friday 19th June 2020;
  - (iv) anyone else who does not meet the definition of a Qualifying Renewal.
5. The winner will be the first Qualifying Renewal to be drawn at random by an independent person on Tuesday 14th July 2020. The winner will be notified by a representative of Celtic by telephone (provided they provided a correct telephone number as part of the Celtic FC Season Ticket renewal process) the same day that the draw takes place, and may be asked to provide further information to facilitate the delivery of their prize. The Promoter reserves the right to re-draw the winner if they cannot be contacted within a reasonable period of time (to be established at the Promoter's sole discretion).
6. The prize shall consist of a refund for the price paid by the winner of that winner's standard Season Ticket (the "Prize") subject to a maximum refund of £766. For the avoidance of doubt, this refund will be only for the face value cost of the standard Season Ticket renewed by the winner as a Qualifying Renewal (and not, for example, the cost of any home cup games which (if applicable) shall remain payable for the duration of the 2020/21 season in respect of that Season Ticket and in accordance with the Season Ticket Terms and Conditions 2020/21).
7. There will only be one Prize. If a winner has renewed more than one Season Ticket, the winner will receive a refund for the winning Season Ticket chosen at random in accordance with paragraph 5.
8. The Prize is non-transferable.
9. The winner (or the winner's parent or guardian if the winner is under 16 years of age) will be required to give their consent to the following: (i) the winner's name to be included in any marketing materials sent out by the Promoter; and (ii) the winner's name and/or photograph to be published for promotional purposes.
10. If the Promoter cannot successfully contact the winner within a reasonable length of time, or if the winner is unable or unwilling to accept the Prize, or if the winner does not meet the eligibility requirements, or the winner (or the parent or guardian of the winner if the winner is under 16 years of age) does not provide the consent requested at paragraph 9 above, a re-draw will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the winner for the purposes of these terms and conditions.
11. The Promoter reserves the right to cancel or amend the Prize Draw or these terms and conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
12. The Prize Draw, together with these terms and conditions, is governed by Scots law and the Scottish Courts will have jurisdiction over any proceedings in connection with the Prize Draw.
13. The Promoter is Celtic F.C. Limited, Celtic Park, Glasgow G40 3RE.
